Participant expectations were very high and the conference met those expectations, which is unusual. It was quite successful.</li> <li>b. Participant feedback expressed a desire for more conferences like this and a repeat next year.</li> </ol> </li> <li>2. Sharon Jaycox noted that feedback from the coalition was very positive</li> <li>3. Sherri Romanowski advocated that we take the conference to Tucson. She has been in discussion with Dr. Dave Alberts with the U of A and believes that the Duvall Auditorium would be available to us.</li> <li>4. Discussion about a possible Tucson conference in the Fall. The group agreed that it makes better sense to follow our current successful conference format and repeat it in a different site since the interest in the material is present, rather than launch off into an unrelated project.</li> <li>5. The group also discussed the possibility of Flagstaff or Prescott conference in 2010 and a repeat, or Part II, in Phoenix.</li> <li>6.
