THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

ACTION MEDICAL SERVICE, INC. - GANADO

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

All the following described area situated in Ganado, County of Apache, State of Arizona, and more particularly described as follows: Lots six, seven, eight, fifteen, sixteen, seventeen, eighteen, nineteen, twenty, twenty-one, twenty-two, and thirty and the south half of the northeast quarter of the southeast quarter of Section twenty-seven in Township twenty-seven north of Range twenty-six east of the Gila and Salt River Meridian, Arizona, containing one hundred five and fifty-three-hundredths acres, according to the Official Plat of the Survey of the said Land, returned to the General Land Office by the Surveyor-General.

Being the same area described and recorded in the records of Apache County on 6 February 1932, in Book 22 of Deeds, page 142-143,

AND

All the following described lands situated in the County of Apache, Arizona to wit: Beginning at the Meander Corner on the south side of Pueblo, Colorado River between Sections 26 and 27 in Township 27 north, Range 26 east, Gila and Salt River Meridian, thence south a distance of 16.64 chains to the fence on

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

authorizing the operation of the aforesaid ambulance service for a period ending October 31, 2018 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.
