THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

ELOY FIRE DISTRICT dba ELOY FIRE DISTRICT AMBULANCE SERVICE

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area and response times:

1. Service Area:

Starting at the intersection of Baumgartner Road and Wheeler Road, go north to Pretzer Road, then east one mile to Citrus Heights Drive or the northeast corner of Section 18, T9S R9E, then north to Hanna Road, then west along Hanna Road to Highway 87, then north to Cornman Road, then west along Cornman road to 11 Mile Corner Road, then north to Selma Highway, then west to Curry Road, then south to Cornman Road, then west to Signal Peak Road (Toltec Road), then south to Arica Road, then west to the northern boundary of Highway 84, then northwesterly along the northern boundary of Highway 84 to Overfield Road, then west to a point of 1923.20 feet east of Sunland Gin Road, then north 1327.86 feet, then west to Sunland Gin Road, then south 827.86 feet, then west 1,437 feet, then south 500 feet, then east 342.04 feet, then south to the northern right of way of Interstate 10, then southeasterly along the northern right of way of Interstate 10 314.96 feet, then south to the northern border of Section 24, T7S R6E, then west 120.00 feet, then south 561.22 feet, then east to Sunland Gin Road, then south to the midpoint of Section 24, T7S R6E, then west to the center point of Section 24, T7S R6E, then south to Shedd Road, then west along Shedd Road

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending October 31, 2018 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.

3. Response Times:


- a. Thirteen (13) minutes on ninety (90) percent of all ambulance calls.*

- c. Twenty (20) minutes on one hundred (100) percent of all ambulance calls.*
