THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

RIO RICO FIRE DISTRICT

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

The Rio Rico Fire District which is an area from one mile North of the Calabasas-Rio Rico Drive Interchange on I-19 to a line running East and West 2 mile South of the Ruby Road Interchange on I-19. The West boundary is a line running North and South between the Northern and Southern boundaries just described and running North and South between the Northern and Southern boundaries and approximately four miles East on I-19. In addition, the Pena Blanca Highlands Subdivision as described in Docket 215, pages 353 through 355, as recorded in the Santa Cruz County Recorder's Office, is included. Service area also includes long distance prescheduled, interfacility or convalescent transports originating in the corporate city limits of Nogales.

2. Central Operating Station: *Rio Rico, Arizona (1194 Pendleton Drive).*

3. Response Times:

- a. *Five (5) minutes on forty five (45) percent of all ambulance calls.*
- b. *Ten (10) minutes on eighty five (85) percent of all ambulance calls.*
- c. *Fifteen (15) minutes on ninety five (95) percent of all ambulance calls.*
- d. *Twenty (20) minutes on ninety nine (99) percent of all ambulance calls.*

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

RENEWAL

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending October 31, 2018 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.
