THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

RIVER MEDICAL, INC. dba LIFE LINE AMBULANCE

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

Beginning at a point on U.S. Highway 93 Milepost 50; then proceeding Northeast to a point approximately 30 miles North of Kingman to Stockton Hills Road; then proceeding East to Anteres Road approximately 20 miles North of Route 66; then due North to the Western border of the HIR; then extending Southeast, East and Northeast along the Southern border of the HIR to its Southeastern border; then Southwest to Interstate 40 Milepost 109 and further Southwest to Wickieup, Arizona; then due East to the Eastern border of the Mohave/Yavapai County border. Then due South along the Mohave/Yavapai County border and the La Paz/Maricopa border to the Southeastern corner of La Paz County. Then due West to the Eastern border of the KNWR. Then due North, West and South along the border of the KNWR to point where the KNWR and the La Paz/Yuma County borders meet. Then due West to the Colorado River. Then following the Western border of La Paz County North along the Colorado River to the Mohave County line, excluding the Colorado Indian Reservation. Then following the Western border of the Mohave County line North to Interstate 40, excluding the Havasu National Wildlife Refuge. Then East from Milepost 1 on Interstate 40 to Milepost 16 on Interstate 40. Then Northwest on line to State Highway 68, Milepost 12. Then Northwest on a line to Highway 93, at Milepost 50. The description shall exclude any Federal or Indian lands. River Medical, Inc. dba Life Line Ambulance may serve such lands to the extent permitted by law.

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

AMENDED

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending July 31, 2019 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.

2. Central Operating Station: *Lake Havasu City, Arizona (415 El Camino Way).*
3. Response Times:
 - a. *Ten (10) minutes on sixty-one (61) percent of all emergency (911) ambulance calls.*
 - b. *Fifteen (15) minutes on seventy-eight (78) percent of all emergency (911) ambulance calls.*
 - c. *Thirty (30) minutes on ninety-three (93) percent all emergency (911) ambulance calls.*
 - d. *Seventy-five (75) minutes on one hundred (100) percent of all emergency (911) ambulance calls, except on Highway 93 South from Milepost 130 to Milepost 150 which may take an additional 20 minutes.*
4. Type of Service: *Immediate Response Transports, Interfacility Transports, and Convalescent Transports*
5. Hours of Operation: *24 hours per day – 7 days per week*
