THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

**RURAL/METRO CORPORATION (MARICOPA)
dba RURAL/METRO AMBULANCE SERVICE
dba ARIZONA MEDICAL TRANSPORT
dba AMT**

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

From a point where Yavapai County line and an extension of 163rd Avenue would meet, east along the county line to the Tonto National Forest. Then, south approximately 9 2 miles to the corner of the Tonto National Forest boundary. Then, east approximately 27 miles to the southwest corner of the Mazatzal Wilderness Area. Then, southeast to mile post 210 on Highway 87. Then, south to the entrance to Lost Dutchman State Park. Then east to the southwest boundary of the Superstition Wilderness Area, then following the southwestern boundary of the Superstition Wilderness Area to an imaginary intersection with a northward extension of Barkley Road. Then, due south on Barkley Road to an intersection with U.S. Highway 60. Then, due west on an imaginary line to Baseline Road where it intersects with the Maricopa County/Pinal County line. Then, due south along the Maricopa County/Pinal County line, following an imaginary extension of the Maricopa County/Pinal County line, to a point that intersects with Hunt Highway. Then, westerly and slightly north to the intersection of Hunt Highway and the Maricopa County/Pinal County line. Then, west on the Hunt Highway alignment to Gilbert Road. Then, due north to the intersection of Gilbert Road and Galveston Street. (continued next page)

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

TRANSFER

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending November 30, 2018 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.

Then, due west along the Galveston Street alignment to Cooper Road. Then, due north along the western boundary of the Town of Gilbert municipal boundaries to the intersection of Country Club Drive (Arizona Avenue) and Western Canal. Then, due west to intersection of Western Canal and Price Road. Then, along the current southern city limits of Tempe and South Mountain Park to the Gila River Indian Reservation. Then, northwest along the Gila River Indian Reservation to Estrella Mountain Park. Then, south along the Estrella Mountain Park border inclusive of the park boundaries to 163rd Avenue north to the Yavapai County line or point of origin. Service area excludes any portion of the City of Chandler.

 - 2) *Fifteen (15) minutes on ninety-five (95) percent of all emergency transports.*
 - 3) *Twenty (20) minutes on one hundred (100) percent of all emergency transports.*
- b. *Otherwise:*
 - 1) *Ten (10) minutes on fifty (50) percent of all emergency transports.*
 - 2) *Twenty (20) minutes on seventy (70) percent of all emergency transports.*
 - 3) *Thirty (30) minutes on eighty-five (85) percent of all emergency transports.*
 - 4) *Sixty (60) minutes on one hundred (100) percent of all emergency transports.*
