THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

RURAL/METRO CORPORATION (PIMA)

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

Starting in the Northwest corner of the junction of Pima and Pinal County Line at I-10 and proceeding East along the Pinal County/Pima County boundary to a point directly North of Kingair Drive and abutting the West boundary of the Golder Ranch Fire District service area. Then along the Golder Ranch Fire District service area boundary South and East and then East, to the West border of the Coronado National Forest boundary, and along its boundary to the Saguaro National Monument boundary. Then along the Saguaro National Monument boundary to the Old Spanish Trail. Then Southward to Rita Road and Houghton Road. South on Houghton Road past Interstate 10 and Sahuarita Road to the boundary of the Coronado National Forest and along its border to the base of the Santa Rita Mountain range to the Pima County/Santa Cruz County border. Then West along the Pima County/Santa Cruz County border to a point five (5) miles West of Interstate 19. Next, due North to the intersection of Pima Mine Road and Avenida Palomino, then East on Pima Mine Road to Mission Road. Then Northeast along Mission Road to Ajo Road. Then West along Ajo Road to the Southeastern boundary of the Tucson Mountain Park. Next, along the Eastern boundary of the Tucson Mountain Park where it meets with the East and South intersecting boundary points of the Saguaro National Monument. Then North along the Eastern boundary of the Saguaro National Monument to Scenic Drive and Silverbell Road where it meets with Lambert Lane. Then East on Lambert to Interstate 10. Next, Northwest along I-10 to the point where Pima

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

TRANSFER

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending July 31, 2018 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.

Service area does not include the approved service areas of the Fire Districts of Avra Valley, Catalina, Drexel Heights, Golder Ranch, and Picture Rocks.

3. Response Times:

a. *City of Tucson:*

- 1) *Eight (8) minutes on seventy (70) percent of all ambulance calls.*
- 2) *Ten (10) minutes on eighty (80) percent of all ambulance calls.*
- 3) *Fifteen (15) minutes on ninety (90) percent of all ambulance calls.*
- 4) *Twenty (20) minutes on one hundred (100) percent of all ambulance calls.*

b. *Green Valley, Northwest Tucson and remainder of Pima County certificated area:*

- 1) *Ten (10) minutes on seventy (70) percent of all ambulance calls.*
- 2) *Twelve (12) minutes on eighty (80) percent of all ambulance calls.*
- 3) *Fifteen (15) minutes on ninety (90) percent of all ambulance calls.*
- 4) *Thirty (30) minutes on one hundred (100) percent of all ambulance calls.*
