THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

ST. JOHNS EMERGENCY SERVICES

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

Service area: The City of St. Johns and the following general boundaries: North from St. Johns on U.S. Highway 191 (formerly U.S. Highway 666) to milepost 344; northeast from U.S. Highway 191 (formerly U.S. Highway 666) at milepost 344 on State Highway 61 to the New Mexico border at milepost 430; east from St. Johns on Apache County Road 6040 to the New Mexico border; South from St. Johns on U.S. Highway 191 (formerly U.S. Highway 666)/180 to milepost 382, a point midway between St. Johns and Round Valley; West from St. Johns to milepost 353 on State Highway 61 at the junction of State Highway 61 and U.S. Highway 60; West from Concho on Apache County Road 6020 to the Navajo County border; West and North from St. Johns on U.S. Highway 180 to milepost 328 at the Apache-Navajo County line. All of the area encompassed by a line drawn from where U.S. Highway 180 crosses the Navajo County border at milepost 328, proceeding in an east-northeast direction to the junction of U.S. Highway 191 (formerly U.S. Highway 666) and state Highway 61 at milepost 344; thence northeast along (and encompassing) State Highway 61 to milepost 430 at the New Mexico border; thence south along the New Mexico border to a point where a line running west-southwest intersects milepost 382 on U.S. Highway 191 (formerly U.S. Highway 666) and continuing in the same direction to intersect the junction of U.S.

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

RENEWAL

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending February 28, 2019 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.

Highway 60 and State Highway 61 at milepost 353; thence north crossing Apache County Road 6020 at the Navajo County border and continuing north to milepost 328 on U.S. Highway 180 at the Navajo County border.

2. Central Operations Station: *St. Johns, Arizona (395 South Washington).*

3. Response Times:

a. *Within the City of St. Johns:*

Fifteen (15) minutes on 70% of all EMS calls.

Twenty (20) minutes on 80% of all EMS calls.

Thirty (30) minutes on 90% of all EMS calls.

b. *Outside of the City of St. Johns:*

Thirty (30) minutes on 60% of all EMS calls.

Forty (40) minutes on 75% of all EMS calls.

Fifty (50) minutes on 85% of all EMS calls.

Sixty (60) minutes on 90% of all EMS calls.

Seventy-five (75) minutes on 99% of all EMS calls.
