THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

## TRI-CITY FIRE DISTRICT dba TRI-CITY FIRE DISTRICT AMBULANCE SERVICE

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

### 1. Service Area:

*Beginning at the intersection of State Route 188 (milepost 232) and Stage Coach Lane (Roosevelt Resort); Thence Northeasterly in a straight line to the intersection of State Route 288 (milepost 265) and Forest Service Road 203 (Cheery Creek Road); Thence East North East in a straight line to a point where U.S. Highway 60 (milepost 286) enters the San Carlos Indian Reservation; Thence continuing in a Southerly direction along the San Carlos Indian Reservation boundary line to a point where the Reservation boundary turns in an Easterly direction; Thence East in a straight line to a point where it meets the Gila River (San Carlos Indian Reservation boundary; Thence in a Southwesterly direction, following the Gila River, to milepost 138 (State Route 77), about three miles from the Town of Winkelman; Thence in a Northwesterly direction to a point where Gila and Pinal counties meet at the southern edge of Section 29, Range 14 East, Township 1 South; Thence West along the Southern edge of Sections 29 & 30, Range 14 East, Township 1 South and Sections 25, 26, 27, 28, 29, Range 13 East, Township 1 South to a point that intersects with U.S. Highway 60 (milepost 229.5); Thence Northeasterly in a straight line to the point of beginning.*

### 2. Central Operations Station: *Claypool, AZ (4280 E. Broadway).*

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

authorizing the operation of the aforesaid ambulance service for a period ending January 10, 2019 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.
