Call To Order:

James Clark called the meeting to order at 2:03 p.m. and read the Executive Session Confidentiality Statement:

"Minutes of and discussions made in executive session are required by law to be kept confidential and shall not be communicated to any person outside this meeting room, except to members of the Board, a person who is the subject of the discussion pursuant to Arizona Revised Statutes (A.R.S.) § 38-431.03(A)(1), the auditor general in connection with an audit authorized by law, and the attorney general."

Dr. Clark swore in individuals who anticipated testifying.

Statutory Hearings:

Sharon Sue Campbell – PSRB No. 18-04

Sharon Campbell was present in person and through counsel, Nora Greer. The statutory hearing was held from 2:04 p.m. to 2:18 p.m. pursuant to A.R.S. § 13-3994(H). ASH recommended limited conditional release so Ms. Campbell could attend to a family emergency.

Dr. Clark explained that ASH recommended that Ms. Campbell is allowed to leave the secure grounds of ASH to visit with her father who is gravely ill.

Dr. Clark stated that the report mentions that the visit will take place in Ms. Campbell's brother's home, and the records indicate that she has two brothers, both of whom live in California. Ms. Campbell clarified that one has moved to Arizona.

Dr. Jaffe clarified that an 8-hour pass will not interfere with oral medication administration and that oral meds will be administered before and after the pass takes place. Dr. Holmes added that the Hospital can affix Ms. Campbell with a GPS device if the Board so wishes.

Ms. Greer stated that Ms. Campbell has a rather short commitment under the Board, and pointed out that the report mentions that the treatment team is considering her for conditional release privileges. Ms. Campbell understands that her conduct during the visit with her father may impact her eligibility for regular off-grounds passes.

A motion was made by James Clark and seconded by Paul O'Connell to grant Ms. Campbell a supervised pass, as recommended by ASH, so that Ms. Campbell can visit her father who is in hospice care in Surprise, Arizona. There is to be no status change to the terms of Ms. Campbell's confinement at ASH. The finding the Board makes today is that Sharon Campbell is in stable remission and not dangerous, and that public safety and protection would not be in jeopardy by the granting of this pass because of the supervision that ASH will be providing. Ms. Shapiro asked the Board to consider a number of added provisions to the order of limited conditional release which included whether or not Ms. Campbell would be directly supervised by the security officers at all times or not. Dr. Holmes clarified that the security staff would escort Ms. Campbell and would remain outside of the room as she visits with her father. Dr. Klemens commented that if direct supervision at all times would not take place, then a urine drug screen analysis upon her return to ASH would be most appropriate. Ms. Greer stated that Ms. Campbell would agree to that provision.

Dr. Clark amended his motion to include that Ms. Campbell will submit a urine drug screen analysis upon her return to ASH, and that Ms. Campbell is affixed with a GPS ankle monitor during her pass. Paul O'Connell seconded the amended motion.

Dr. Clark called for a vote by roll call and it passed 4 – 0:
Dr. Klemens voted aye.
Ms. Stevens voted aye.
Mr. O'Connell voted aye.
Dr. Clark voted aye.

Adjournment:

The Board meeting was adjourned 2:19 p.m.
