### CERTIFICATION OF SMALL ENTITY STATUS FOR THE PURPOSES OF ANNUAL FEES IMPOSED UNDER R9-7-1304

A licensee who qualifies as a small entity under a specific size standard established by the Arizona Department of Health Services (ADHS) may pay a reduced annual fee by filing the required certification on ARRA FORM 333, which is on page 1. A separate ARRA FORM 333 is required for each invoice. Licensees who do not qualify under one of the size standards shown on ARRA FORM 333 should disregard this form.

- 1. Complete all items on ARRA FORM 333 as follows: (NOTE: Incomplete or improperly completed forms will be returned as unacceptable.)
  - Enter the licensee's name and address exactly as they appear on the invoice. Annotate name and/or address changes for billing purposes on the payment copy of the invoice Correcting the name and/or address on ARRA FORM 333 or on the invoice does not constitute a request to amend the license.
  - Enter the invoice number exactly as it appears on the invoice.
  - Enter the company's business telephone number.
  - Enter the license number exactly as it appears on the invoice.
  - Enter the contact person's name and email address. Enter the company's website address (if applicable), and the contact person's telephone number.
  - Check the appropriate size standard under which the licensee qualifies as a small entity. Check one item only. Note the following:
    - a. A licensee who is a subsidiary of a large entity, including foreign entities, does not qualify as a small entity. The calculation of a firm's size includes the employees or receipts of all affiliates. Affiliation with another concern is based on the power to control whether exercised or not. Such factors as common ownership, common management and the identity of interest (often found in members of the same family, among others, are indications of affiliation).
