Examples of Arizona State Government Agencies that will NOT be charged a fee for Certified or Noncertified Copies of a Certificate

Effective July 1, 2009, The Bureau of Vital Records will no longer provide free copies (certified or non-certified) to non-Arizona State government agencies. All requests for certified or non-certified copies of vital records must be accompanied by payment of the appropriate fees.
