COVID-19 Vaccine Finder Information Frequently Asked Questions (FAQs)

How can **Healthcare Workers** get vaccinated?

During Phase 1A, health care workers, emergency medical services providers, and health support occupations are recommended for vaccination, because they are critical infrastructure workers at highest risk for acquiring COVID-19 while on the frontlines providing health care services for patients. As state and local providers move through the vaccination phases, health care workers will continue to be eligible to receive COVID-19 vaccine.

How can **Long-Term Care Residents** get vaccinated?

During Phase 1A, long-term care residents and older adults living in congregate settings are recommended for vaccination, because they are at highest risk for severe COVID-19 disease including hospitalization and death. As state and local providers move through the vaccination phases, long-term care facility residents will continue to be eligible to receive COVID-19 vaccine.

The [CDC Pharmacy Partnership for Long-Term Care](#) with CVS and Walgreens will provide onsite vaccination for long-term care facilities that enrolled in the program, starting with skilled nursing facilities. Assisted living facilities and other residential congregate settings that have enrolled in the program may be contacted by mid-January to begin scheduling onsite vaccination clinics.

If your facility has **not** enrolled in the federal program to receive onsite vaccinations from CVS or Walgreens, please contact the [County Health Department](#) in the jurisdiction where you live or work.

How can **Adults 75 and Older** get vaccinated?

During Phase 1B, adults 75 years and older are recommended for vaccination, because they are at highest risk for severe COVID-19 disease including hospitalization and death. As state and local providers move through the vaccination phases, adults 75 and older will continue to be eligible to receive COVID-19 vaccine.

How can Education and Child Care Providers get vaccinated?

During Phase 1B, education and child care providers are recommended for vaccination, because they are critical infrastructure workers at high risk for acquiring COVID-19 while working on the frontlines. As state and local providers move through the vaccination phases, education and child care providers will continue to be eligible to receive COVID-19 vaccine.

How can Law Enforcement and Protective Services get vaccinated?

During Phase 1B, law enforcement, corrections, courts, and other protective services workers are recommended for vaccination, because they are critical infrastructure workers at high risk for acquiring COVID-19 while working on the frontlines. As state and local providers move through the vaccination phases, law enforcement, corrections, courts, and other protective services workers will continue to be eligible to receive COVID-19 vaccine.

How can Adults 65 and Older or with High-Risk Medical Conditions get vaccinated?

These high-risk populations will be included in Phase 1C. Please check back for more information regarding how to make an appointment when vaccination sites are open for Phase 1C populations. During Phase 1C, adults 65 years and older or with high risk medical conditions are recommended for vaccination, because they are at highest risk for severe COVID-19 disease including hospitalization and death. As state and local providers move through the vaccination phases, adults age 65 years and older or with high risk medical conditions will continue to be eligible to receive COVID-19 vaccine.

How can Essential Employees* get vaccinated?

Additional frontline essential workers will be included in Phase 1B-1C as vaccine availability increases statewide. While vaccine supplies are limited, please complete the [Essential Employer Vaccine Request Form](#) with population estimates by county to be considered for vaccination as supplies become available.

During Phase 1B-1C, essential workers are recommended for vaccination as supplies become available, because they are at high risk for acquiring COVID-19 while working on the frontlines. As state and local providers move through the vaccination phases, essential workers will continue to be eligible to receive COVID-19 vaccine.
